1. Apologies

5. Minutes

The minutes of the meeting held on Thursday 20 March 2025 were agreed and signed by the Chair.

6. To receive reports from County/District Councillors/Police and Public Questions

- 6.1 The district councillor reported that a member grant had been renewed and the parish council were able to access funds for projects around the village.
- 6.2 There was no police update
- 6.3 Members of the public raised the following points:
 - Speed limits throughout Bawburgh
 - The pond on Stocks Hill the PC reported that this could not be claimed by the parish council until it had been released by the local authority through the owner of the development.
 - The village green issues with recent travellers.

7. Previously reported items

7.1 Footpaths and John Innes Centre (JIC)

There was nothing to report.

7.2 Electric Car parking charging points and solar panels

The solar panels had been put in place and were generating energy. Some slabs needed to be laid for the electric car charging points. It was clarified that the running of the charging points would be the responsibility of South Norfolk Council however the final details were being clarified. There was also a need for some cross hatching or similar to allow charging to be carried out safely and the parish council were aware of health and safety issues that needed rectifying.
