1. Apologies

Apologies had been received Phil Hardy (District Councillor).

2. Interests

There were no interests declared.

3. Minutes

The minutes of the meeting held on 20 August 2020 were agreed and signed by the Chairman; subject adding 'concern' after major at 8.1.

4. To receive reports from County/District Councillors/Police and Public Questions

- 4.1 County Cllr, David Bills reported that the plans for the Thickthorn roundabout had changed. He also explained technology that was being used to help identify where in the County to send gritters and to help farmers with moisture levels.
- 4.2 The District Councillor reported that the Gypsy site had been closed and was considered unsafe. The planning application at Harts Lane was refused on 23 September and the application at Hockering land had not been called in, but was approved with conditions on 26th August 2020. The Council's Environment Report Recycling Initiatives was being discussed at the first Environment Committee meeting.
- 4.3 The Police report was **NOTED.**

5. Previously reported items

5.1 Gypsies and Travellers Short Stay Site

The short stay site had remained close. The Chairman was physically and verbally assaulted in helping to deal with the illegal encampment of the travellers on the Village Hall car park. It was reported the family concerned could be offered alternative accommodation or a plot on a permitted site, Sam Porter, developer of the site next to the Village Hall, would help by blocking the entrance of the Village Hall as they were no events taking place due to Covid-19.

5.2 **Boundary Review**

There was no update due to the Coronavirus pandemic.

5.3 Norwich Western Link project

The next meeting was scheduled in December.

5.4 Hornsea Project

This was minded to be approved by the Secretary of State allowing further information from the applicant. The deadline was now December.

- 6.1 The Council discussed at length the recent installation of the chicanes on Stocks Hill to help prevent speeding traffic through the Village.
